## State Forest



**LOCATED IN THE SOUTHEASTERN CORNER** of West Virginia near the state of Virginia's border, **Greenbrier State Forest** provides more than 5,100 acres of heavily forested, mountainous terrain for outdoor recreation. Magnificent views of the surrounding countryside are complimented by the impressive and imposing 3,200-foot high Kate's Mountain.

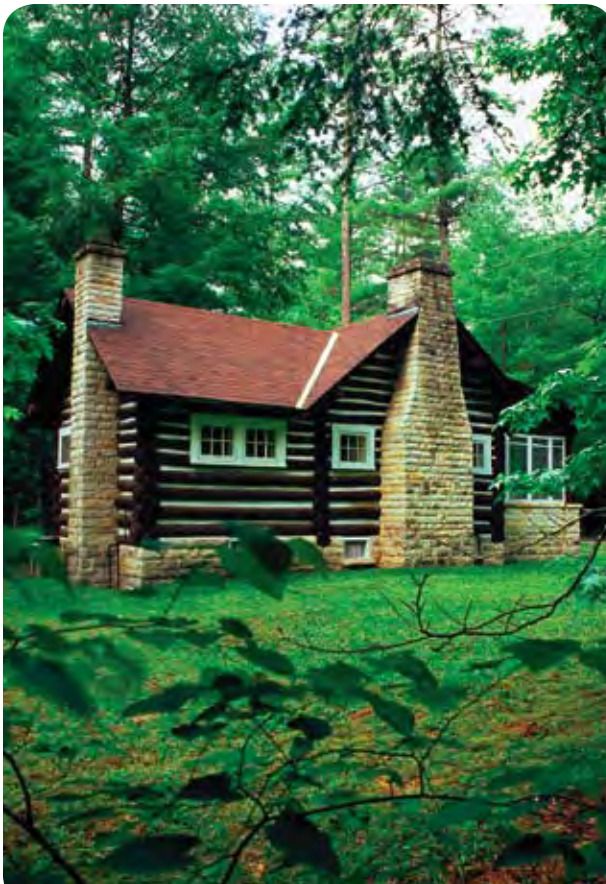
### Vacation Cabins

- 12 standard cabins
- One accessible cabin
- Wood-burning fireplace
- Fully equipped kitchen
- Completely furnished for housekeeping
- Cots and cribs available, fees apply
- Open mid-April through Oct. 31
- Check-in time is 4 p.m. and check-out is 10 a.m.



### Campground

- 16 sites, featuring electric hookup, picnic table and stone fireplace with grill
- Central bathhouse with hot showers and restrooms
- Open mid-April through deer rifle season
- Perfect for tent camping and units up to 32 feet
- Only one tent or trailer per site
- Dump station facilities nearby, fee based
- Check-out is noon



## RESERVATIONS

Reservations may be made by writing or calling Greenbrier State Forest directly or by dialing 1-800-CALL WVA and asking for Greenbrier State Forest. This toll-free line may be used anywhere in the continental United States or any Canadian province in the Eastern time zone.

### Cabin Reservations

When making cabin reservations for four nights or more, a deposit of one-half the rental fee is required with the balance due upon arrival; the full rental fee is required for reservations of three nights or less.

Those who make reservations by telephone have 10 days to make deposit payments. Reservations made less than 10 days of arrival, as available, are accommodated and a method of guarantee provided at the time the reservation is made.

During the summer season (second Monday in June through Labor Day), the cabins are reserved for one to two week periods only. Before and after the summer season, cabins may be rented by the day, two-day weekends or longer.

Reservations may be made up to one year in advance (from the first day of the month of planned stay) and are recommended at all times.

Greenbrier State Forest may offer three- or four-night rental options. If rentals of less than a week are desired, ask about shorter rental periods.

Check-in time begins at 4 p.m., with check-out at 10 a.m.

### Campsites

The campground is seasonal in operation. Reservations are taken for 50 percent of the campsites designated for reservations from the Friday before Memorial Day through Labor Day. Campsite numbers will not be guaranteed; however, every effort will be made to assign the campsite requested. The remaining sites are available on a first-come, first-served basis.

Only one camping unit per site is permitted.



After Labor Day and prior to observed Memorial Day weekend, all campsites are on a first-come, first-served basis, as available. A minimum stay of two nights, up to a maximum of 14 nights, is required when making campsite reservations.

Reservations must be made at least 48 hours or more in advance of arrival, as available. Full payment and a \$5 handling fee per site are required.

Online reservations are not available for campsite rental.

Reservations are made for the year beginning each Feb. 15. Only mail-in reservations will be taken from Feb. 15 – March 14. Mail-in reservations postmarked before Feb. 15 will be returned. Phone reservations, in addition to mail-in reservations, will be taken beginning March 15. Walk-in, mail-in, and phone-in reservations will be taken beginning April 1 and throughout the season, as available.

Reserved campsites that are accessible to persons with disabilities will be held for such individuals to reserve from Feb. 15 – March 14. Proof of disability must accompany the deposit, and the site must be occupied during the reservation period by the disabled individual for the reservation to be honored. Beginning March 15, the sites will become available for all rentals. All other current reservation procedures besides those described above will remain the same.

### Cancellations

**Cabins:** Deposits will be returned, less a handling fee per unit canceled, if notice is given at least 30 days in advance.

**Campsites:** The full deposit will be refunded, less the handling fee and the first night's campsite fee, when cancellation is more than seven days in advance of arrival. Cancellations for campsite rentals less than seven days prior to arrival forfeit the full deposit and handling fee for the campsite.

### Pet-friendly

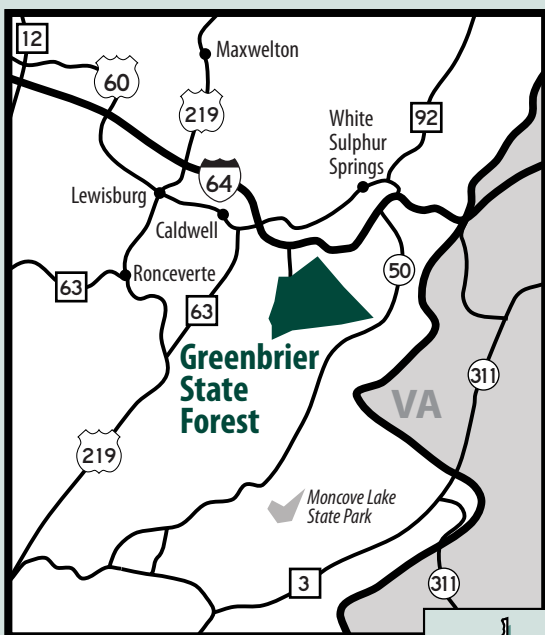

### Payment Methods

Personal checks, money orders and major credit cards (VISA, MasterCard, American Express, Discover and Diners Club) are accepted for all reservations. Identification may be requested.

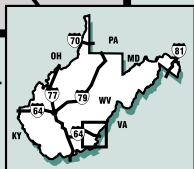
